## NOTIFICATION FOR ISAE AWARDS (2018)

**(Last Date for Nominations/Applications: November 15, 2018)**

ISAE invites nominations/applications for the following AWARDS to recognize the outstanding contributions of its Members in the field of Agricultural Engineering and also in the fulfillment of the ISAE's objectives. Only those candidates will be considered who are either Life Members or Corporate Members or Student member as applicable to the concerned award by the last date of submitting the applications.

**1. Mason Vaugh Agricultural Engineering Pioneer Award (by Nominations only):** This award will be the highest recognition by the Society and will be awarded to any person who has fulfilled the following criteria:

- a) Life Member of ISAE for 25 years b) ISAE Fellow
- c) ISAE Gold Medalist
- d) Outstanding Professional contribution in one of the following area:  
Establishment/improvement of Agricultural Engineering Education in India

**and/or**

Pioneering research contribution that lead to greater recognition to Agricultural Engineering Profession

**and/or**

Pioneering efforts in field applications of agricultural Engineering technologies leading to mass adoption by industry/farmers

**and/or**

Pioneering efforts made by Industry/Corporate Member in industrial sector of any recognized field of agricultural engineering with large scale employment of agricultural engineers and making available quality commercial product of international standards to Indian farmers.

*Nominations for this award from persons are required to be sent directly to the President, ISAE.*

**2. ISAE GOLD MEDAL FOR LIFE TIME ACHIEVEMENTS (by nominations only)** – will be awarded to any life member fulfilling following criteria and to be nominated by ISAE Gold Medalist/Past President:

- a) Life Member of ISAE for 20 years b) ISAE Fellow

c) Contributions made to ISAE in various capacities include significant contributions made as executive committee/council member of ISAE and its Chapters, editors of ISAE publications, reviewer of journal articles, organizing national/regional conventions, enrolling large membership, improving financial position of ISAE, presiding over ISAE committee nominated by ISAE Executive Committee for its various activities and any other significant contribution made to ISAE as professional body to support mandate of ISAE at national/international level.

d) Outstanding Professional contribution in one of the following area:

i) **Education:** Establishment/improvement of Agricultural Engineering Education in India to be judged on the basis of establishment of new Agricultural Engineering Institution, design of new courses & contents, guidance to PhD and Masters students leading to recognition of students thesis by national/international awards.

**and/or**

ii) **Research:** Pioneering research contribution that lead to greater recognition to Agricultural Engineering Profession to be judged on the basis of quality of research publications in highly rated research journals, Citation index, recognitions of research by national/international bodies, patents, product development & commercialization, adoption of research outcome by stakeholders including farmers.

**and/or**

iii) **Field/Extension:** Pioneering efforts in field applications of agricultural Engineering technologies leading to mass adoption to be judged on the basis of supporting evidence of

(1) Introduction of new implements and tools technology with large scale adoption, **or**

(2) introduction of innovative land water management treatments leading on large scale area treatment for soil moisture security,

**or**

(3) Introduction of innovative irrigation system leading to mass adoption and evidence of enhanced water productivity

**or**

(4) Introduction of innovative energy gadgets leading to mass energy conservation as evidenced from local government reports,

**or**

(5) introduction of any post harvest, processing, value addition technology and mass scale adoption by users as evidenced from market penetration of such products.

**and/or**

(6) **Industry:** Corporate Member with pioneering efforts in establishment of industry in any recognized field of agricultural engineering that lead to large scale employment of agricultural engineers and making available quality commercial product of international standards to Indian farmers to be judged on the basis of number of agricultural engineers on roll, market share in Indian market, annual domestic sale and export. Industry should be at least 15 year old and should have been recognized by central/state Government agencies for its quality product and services to farmers.

3. **ISAE FELLOW** – will be awarded to any Life Member fulfilling following criteria and to be recommended by two ISAE Fellows:

(a) Life Member of ISAE for 15 years

(b) Contributions made to ISAE in various capacities include significant contributions made as executive committee/council member of ISAE and its Chapters, editors of ISAE publications, reviewer of journal articles, organizing national/regional conventions, enrolling large membership, improving financial position of ISAE, presiding over ISAE committee nominated by ISAE Executive Committee for its various activities and/or any other significant contributions made to further the goals of ISAE as

professional body in any of the thematic areas at state, national or international level.

(c) Outstanding Professional contribution in one of the following area:

(i) **Education:** Establishment/improvement of Agricultural Engineering education in India to be judged on the basis of establishment of new Agricultural Engineering Institution, design of new courses & contents, guidance to PhD and Masters students leading to recognition of students thesis at national/international level.

**and/or**

(ii) **Research:** Pioneering research contribution that lead to greater recognition to Agricultural Engineering Profession to be judged on the basis of quality of research publications in highly rated research journals, Citation index, recognitions of research by national/international bodies, patents, product development & commercialization, evidence of adoption of research outcome by stakeholders including farmers.

**and/or**

(iii) **Field/Extension:** Pioneering efforts in field applications of agricultural Engineering technologies leading to mass adoption to be judged on the basis of supporting evidence of (a) introduction of new implements and tools technology with large scale adoption, **or** (b) introduction of innovative land water management treatments leading on large scale area treatment for soil moisture security, **or** (c) introduction of innovative irrigation system leading to mass adoption with evidence of enhanced water productivity, **or** (d) introduction of innovative energy gadgets leading to mass energy conservation as evidenced from local government reports, **or** (e) introduction of any post harvest, processing, value addition technology and mass scale adoption by users as evidenced from market penetration of such products.

**and/or**

(iv) **Industry:** Corporate Member with pioneering efforts in establishment of industry in any recognized field of agricultural engineering that lead to large scale employment of agricultural engineers and making available quality commercial product of international standards to Indian farmers/consumers. Annual domestic sale and export record. Industry should be at least 15 year old and should have been recognized by central/state Government and evidence of consumer acceptance for its quality product and services to farmers.

**Note:** *Very senior Agricultural Engineers or Engineers with long experience with outstanding contribution in any field of Agricultural Engineering who could not become Member of ISAE for some reason should be eligible for awarding 'ISAE Fellow/Honorary Fellow' and may be exempted from (b) above on Membership duration criteria. Non Engineers who have made significant contribution to profession of Agricultural Engineering may be awarded with 'Honorary Fellow'. These decisions shall be exclusively made by the President ISAE with approval of Executive Committee and should be considered only in exceptionally deserving cases.*

#### **4. COMMENDATION MEDAL FOR PROFESSIONAL ACHIEVEMENTS**

Will be awarded to any Life Member fulfilling following criteria:

- a) Member in good standing /Life member of ISAE for 10 years
- b) Recommendation by Head of the organization/ISAE chapter certifying the validity of claims made by candidate

c) Contribution of candidate in any one of the discipline i.e ( a ) Farm Power & Machinery (b) Soil & Water Conservation Engineering/ Irrigation & Drainage Engineering (c) Energy in Agriculture (d) Post harvest, process and food engineering along **with supporting evidence** in one of the following thematic fields.

- (i) Development of innovative technology leading to mass adoption including information technology in agriculture
- (ii) Field application of technology leading to enhancing productivity of soil/water/energy/crop/livestock
- (iii) Industrial production, quality control and services to users including training, demonstrations and field services
- (iv) Introduction of new course curricula with design and contents **and/or** introduction of innovative method of teaching/learning

**5. DISTINGUISHED SERVICE AWARD** – Merit Certificates in the similar fields as mentioned in Serial No.4 above are awarded to the Life Members fulfilling following criteria:

- a) ISAE Member of good standing/ Life member for 5 years
- b) Recommendation by Head of organization/ISAE chapter
- c) Professional Services to ISAE in any of the following area with supporting evidences:
  - (i) Enrollment of 20 or more ISAE Life Members in one year
  - (ii) Generating significant finances to ISAE
  - (iii) Organizing local/regional/national seminars under umbrella of ISAE
  - (iv) Providing Agricultural Engineering Services in the state under ISAE Chapter
  - (v) Promotion of Agricultural Engineering Profession at political and bureaucratic system at state, national and international level.

**Women professionals/Engineers working in State or Central Government /Professionals working in Industry. All three category will be adjudged separately.**

**6. ISAE TEAM AWARD** – To be awarded to those Engineers/Scientists fulfilling following criteria:

- a) Team leader must be good standing Member or Life Member of ISAE for 10 years.
- b) Interdisciplinary team work lead by Agricultural Engineer
- c) Contribution of team in research, teaching, extension, industries or field application as evidenced from published literature, innovative products and patents, adoptions levels of technology in any one of the disciplines of agricultural engineering leading to enhanced productivity, economic use of resources and improving economics of agriculture.

**7. OUTSTANDING BOOK AWARD** – To be awarded to author(s) for good quality books in any area of Agricultural Engineering. First edition of the book published and in circulation prior to 2018 will only be considered. Authors must fulfill the following criteria:

- (i) First Author must be ISAE Member in good standing/Life Member
- (ii) Original book authored on topic of agricultural engineering
- (iii) Importance of theme and quality of contents
- (iv) Organization of chapters, scientific editing and language
- (v) Foreword by distinguished experts and their views on contents
- (vi) Meeting expectations of desired audience/readers of book
- (vii) Edited books may not be considered for this award.

- 8. STUDENT PAPER AWARDS** – To be awarded to any Under-Graduate or Post-Graduate student who is a Member of ISAE, and his/her paper is judged as the best paper based on the content, quality and presentation, by a panel of jury. Only the papers presented during the forthcoming 53<sup>rd</sup> Annual Convention of ISAE being held in January, 2019 will be considered for this Award. The papers should preferably be by an individual student. The length of an Under-Graduate Student Paper shall not exceed 2000 words and that of Post-Graduate Student 3000 words. Best UG/PG student selected for this award will be awarded a cash prize of Rs. 5000/- by ISAE.
- 9. JAIN IRRIGATION AWARD** – To be awarded to the Members for the (a) best student paper and (b) best professional paper presented in the area of drip irrigation during each Annual Convention. The papers should preferably not exceed 3000 words.
- 10. BEST CHAPTER AWARD** – To be awarded to the best ISAE Chapter based on following criteria:
- (i) ISAE chapter that hosted previous Annual Convention shall be given top priority for this award in recognition of quantum of efforts put in by the chapter in organizing ISAE convention and mobilizing funds for ISAE.
  - (ii) Other ISAE chapters may also be considered for award if they have organized regional conventions under umbrella of ISAE on mandated themes and also generated significant finances for ISAE.
- 11. ISAE–TAFE Student Gold Medal Award** – Only ISAE members/student members with specialization in Farm Machinery and Power (Thesis/Dissertation should be related to Farm Mechanization. It must have been submitted during calendar years 2016 to 2018). Please submit only Extended Abstract (not more than 4 pages in Times New Roman, Font 12). Also, submit soft copies of papers published/accepted for publication. From a College/Department Only one candidate each to be recommended from B.E./B.Tech., M.Tech., and PhD candidates. The application must be certified by the Dean/Head of the College/Department

## GENERAL CRITERIA AND INSTRUCTION FOR AWARDS

Awards will be made only if, in the opinion of the Awards Committee, the recognition is due. Awards will be given to only Life members/Corporate members/Student members as applicable to the concerned award.

In deserving cases, when the Committee so decides, under the same category, more than one award can be given.

The decision of the Committee is final and no appeal will be entertained.

(a) The recipient of any individual awards within last 3 years is not eligible for award. (b) Any office bearer of ISAE either Ex-Committee or Ex.-Council of ISAE is not eligible for any individual award during his / her tenure. (c) No one is eligible for award if his professional service/contribution to Profession for Agril. Engg. is less than 10 years unless mentioned. While deciding the awards, the contribution to ISAE must be given significant importance.

Nomination(s) for Awards at **Serial No. 1** by at least three ISAE Gold Medalists/past presidents and to be decided by Executive Committee of ISAE. Nominations for awards at Serial No. 2 by ISAE Gold Medalists/Past Presidents. Recommendation for award at Serial No.3 by two ISAE Fellows. **For Serial No. 2 (Gold Medal) and Serial No. 3 (Fellow)** please use the prescribed **Proforma-1**.

Applications for awards at serial numbers 4 to 8 should be sent through proper channel (to be forwarded by the Head of Institution/Organization/Department/ISAE Chapter). For award at Serial No. 6, the team work should be reflected by published literature and a certificate from the Head of the Department/Institution.

For Award at Serial No. 7, the book should be related to any area of the Agricultural Engineering. This should be in the printed form and should be written in English or in Hindi only. A copy of the Book along with Application should be sent by registered post to the ISAE Head Quarters.

For awards at Serial No. 8 and 9, the Vice-President (Technical) in consultation with the respective Technical Directors will recommend the name(s) for these awards, based on the quality of papers presented in the technical sessions, during the 53<sup>rd</sup> ISAE Annual Convention.

For awards at **Serial No. 8 and 9** abstract for the paper shall be sent to Director Awards by 31<sup>st</sup> December 2018. Full text of the paper should be brought for the presentation during the 53<sup>rd</sup> Annual convention. The Award shall be subject to minimum number of 5 participants. The Director (Awards) may, however, relax this condition depending upon the quality of the papers received.

Nominations for award at Serial No. 10 shall be sent by the Chairman of the ISAE Chapters with full report and audited account for 2017-2018.

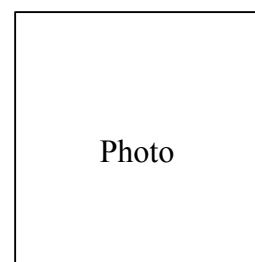

One college may nominate not more than one each for B.Tech, M.Tech, and Ph.D, respectively.*
